## **46.2018** General Data Protection Regulation

- a. *Data audit schedule* Printed copies of the data audit schedule were given to all councilors present, D Whitworth gave his copy to members of the public and then complained that he did not have a copy, the public then gave the copy back. The schedule was discussed in detail and it was agreed to delete the reference to Allotments. A Daniels proposed that the schedule be adopted, four votes for, D Whitworth abstained.
- b. *Email addresses* The new web site gulworthyparishcouncil.gov.uk was now up and running and individual emails addresses were being made for each councilor
- c. *Council telephone* There was a need for the council to have a separate telephone from the clerks private one. It was agreed to purchase a mobile phone.

- d. Local Council Community Cloud It was agreed to see how the new web site performed before considering if any action was needed to be taken on this item
- e. *Information commissioners office registration* There may be a need to register the council with the Information Commissioners office, further information to be sought.
